

BBRSDA APPROVED Board Meeting Minutes

May 9, 2018 – 3:00 p.m. ADT Teleconference

1. Call to Order/Establishment of Quorum

Chairman Friccero called the meeting to order at 3:08 p.m. ADT. Present were board members Friccero, Solberg, Christensen, and Williams; Gibbons joined at 3:20 p.m. Absent were Johnson and Wood. Staff members present were Padilla and Aspelund. A quorum was established.

2. Approval of Agenda

Williams moved and Solberg seconded to revise the agenda to include Resolution 18-02 dealing with Wells Fargo signatories and key executive, Copper River Seafoods' Ice RFP response, and potential Schindler USACE Pebble Scoping Comments. MOTION CARRIED UNANIMOUSLY.

4. Ratify Email Votes

- A. Avitus Executive Director Recruitment Contract Solberg moved and Williams seconded to ratify the Avitus Executive Director Recruitment Contract email vote. MOTION CARRIED UNANIMOUSLY.
- B. 2018 Wink Research Sockeye Market Reports Contract Williams moved and Christensen seconded to ratify the Wink Research Sockeye Market Reports Contract email vote. MOTION CARRIED 3/0 WITH SOLBERG RECUSING.
- C. Interim Executive Director Contract Williams moved and Solberg seconded to ratify the Interim Executive Director Contract email vote. MOTION CARRIED UNANIMOUSLY.

Christensen moved and Williams seconded to go into Executive Session at 3:16 p.m. to discuss personnel. MOTION CARRIED UNANIMOUSLY.

The board exited Executive Session at 3:38 p.m. Gibbons moved and Christensen seconded to execute an employment contract with the new executive director candidate. MOTION CARRIED 4/0 WITH SOLBERG RECUSING.

6. Miscellaneous Business

A. Resolution 18-02 – Wells Fargo Signatories and Key Executive Williams moved and Christensen seconded to approve Resolution 18-02. MOTION CARRIED UNANIMOUSLY.

B. Ice RFP – Copper River Seafoods

Copper River Seafoods determined that it would rather use the funding allocated \$41,916 previously allocated to totes purchase and the balance toward its ice machine to solely using those funds towards the ice machine purchase.

Gibbons moved and Solberg seconded to reallocate the approximately \$41,916 to Copper River Seafoods previously allocated to totes and the balance to the ice machine all to the ice machine. **MOTION CARRIED UNANIMOUSLY.**

C. Potential Schindler Pebble USACE Scoping Comments

Solberg advised that the BBRSDA is uniquely situated to utilize the science it has funded in Bristol Bay to provide comment to the U.S. Army Corp of Engineers during its current Pebble scoping comment period. He's reached out to Daniel Schindler to see if he has a graduate student that could be hired to summarize the science previously funded that could be submitted.

Padilla was directed to solicit a proposal from Schindler for a two-page white paper that could be considered at the June 9, 2018 board meeting.
